Distribution of salmon licences is currently unattractive due to the 50% reduction in licence distributor commission, the time required to process licences and issue additional tags and the withdrawal of the online payment portal on the Bradan system for licence distributors. The sale of a €100 annual all Ireland licence has a commission of €5 while the credit card transaction fee for the retailer could be as much as €3 depending on the type of card payment. Distributors could continue to issue salmon tags as often there is a long delay in anglers receiving these from an online purchase and distributors often already have to issue tags to enable anglers to fish.

Recompense should reflect the ongoing work involved of interacting with licence holders, issuing additional tags etc. Recompense should also be structured in a transparent and fair manner. When the conservation fund levy was introduced this amount was completely disregarded for commission purposes despite clearly being defined in legislation as being part of the "licence fee" on which commission had traditionally been paid. This effectively resulted in a 50% reduction of commission for distributors.

#### In your view how can the current system be improved?

The current Salmon and Seatrout licence and tagging scheme can be improved on by making it efficient and effective. Neither of which is currently the case.

The current scheme captures little more than half of the available data via logbook returns. The logbooks that are returned must be deciphered and interrogated manually. This is both difficult, in terms of interpreting individual handwriting which has often been exposed to wet conditions over the course of a season and inefficient as scarce human resources are employed manually transcribing data.

The data that is compiled is available too late to inform "scientific" management decisions for the following season. Most anglers would be surprised to learn that each year's catch advice is based on inspector's estimates which are at considerable variance to the actual catch returns submitted annually by anglers. For example the estimated rod catch figures, used for management advice, for spring salmon on the river Laune in 2020 was 720 salmon. The actual figure for spring salmon as compiled from angler logbooks was 160. The estimated rod catch figure for spring salmon on the river Drowes in 2020 was 42. The actual figure for spring salmon as compiled from angler logbooks was 89 salmon.

Clearly any licence and tagging system must be able to deliver the necessary information in time to accurately inform the following years management decisions. It should also make the manual transfer of often indecipherable information by fisheries staff unnecessary. I believe the most efficient and effective way to modernise the process is to introduce an app/digital based salmon and sea trout licence. There are many real world examples of such systems in the private and public sphere, including in the fisheries sector. Data, names, addresses etc would be inputted by the end user, greatly reducing input errors in name and address spellings etc, resulting in more complete data which would be searchable and thus more valuable. Furthermore more data could be collected by enforcing a policy of no licence return, no licence renewal. This would greatly reduce the average of 43.6% of licences which are unreturned over recent years. This would also improve the accuracy of overall catch returns as a greater level of returns would reduce the reliance on Bayesian inference and the need for raising factors to account for unreturned data.

Ireland has a strong record in salmon management and the innovative use of technology. Any modernisation of the paper based licencing system, which has remained largely unchanged since the foundation of the state, is an oppourtunity to make the Irish salmon and seatrout licencing system world beating. We have the oppourtunity to develop a truly innovative licencing system which, if done properly, could give us access to more information than has been available to those involved in salmon management anywhere at any time. An app based system would allow this information to be available in real time. Not only could anglers input details of their catch live from the riverbank. Each smartphone has the ability to include GPS coordinates, weather, temperature details, even water heights if integrated with existing OPW information. Perhaps most importantly real data on fishing effort, time spent etc, could be extracted, in real time rather than a random "number of days fished" entered on a licence at the end of the season.

In the spirit of citizen science, anglers could upload photographs of fish, even scale samples for further analysis. Not only would such an app based licence be a means of gathering data in real time it would also be an ideal way of disseminating information in real time to anglers. In recent years very warm water temperatures have become more common, leading to suspension of c&r or of angling altogether. This type of alert could be delivered to anglers quickly and efficiently. Similarly a licencing app could be a means for anglers to report poaching and pollution incidents in real time. The current paper based licencing system is expensive. Licences delivered digitally, through an app could be bought online. On site licence distributors could provide salmon tags where needed as the lead in time for tag delivery is up to a week.

On the question of recompense for licence distributors. It is a welcome development to seek the views of salmon licence distributors on changes to the licencing system and level and type of recompense.

Personally I would see a need for very little recompense for the distribution of salmon tags alone as part of an improved system.

However I would like to see the historic issue of the halving of licence fee commission from 2007 being addressed.

To whom it may concern

In answer to the questions posed - the current system is over complicated. The salmon tag system is fine. The sea trout tags are of no use. The bag limit on sea trout is never enforced by the water bailiffs. Instead the bailiffs are checking for licences for a cash driven system. Fewer children are now on the river because they are afraid to fish for fear of being approached by bailiffs. These children do no pose a threat to stocks of fish. Abolish the licence for children up to the age of 16. Fishing for children in this area will soon be a thing of the past if the current system does not change. Enforce the bag limit checks strictly and be seen to do so for sea trout. Do not turn a blind eye because the fisherman has a licence.

#### Where do you see your role in a more modernized process?

Q. 2 My role at present is collecting money for I.F.I. at a 5% commission rate which is a joke. I have no intention of being any assistance with any enquiries whether they be local or visiting tourists. Instead I will give the phone details of I.F.I. and they can seek answers from a non existent help line.

#### What level and type of recompense do you think should be put in place in a new system??

Q.3 My commission must return this year to a minimum of 10% of all monies collected on behalf of I.F.I. My commission before the conservation stamp was imposed was 10%. Return all distributors to this level starting this year 2021. I have been in contact with the CEO on this matter and he replied to my registered letters through and not with a personal reply.

#### What other services or supports would you feel you should be receiving from IFI?

Q.4 Fishing in this area is over complicated and I have stopped trying to explain where to fish, what bait, lures, flies can be used and where is free fishing and where is private. Supply me with a dedicated daytime phone number to explain this to tourists who are stunned when I have tried to explain the fishing regulations. Most people give up and go elsewhere or just don't fish. Again I have no intention of acting as a free advice service for I.F.I.

What steps should IFI take to improve the overall customer experience of the scheme?
Q.5 The overall customer service experience in is horrendous as explained in Q.4. This I suspect will not change until pressure is applied at a government level. Hopefully all activities and practices of I.F.I. will be examined at this stage.
How likely are you to move to a totally online platform?
Q.6 When I.F.I. supplies my shop with all the necessary tool/equipment and training and pays a rate of commission in line with such work I might consider it. I do feel this question is just a PR stunt as do many other distributors as there is, I feel, no chance whatsoever of this becoming a reality.
Just to finish, up to now a licence could be obtained at my premises from 9a.m. until 10p.m. This is no longer the case. Bailiffs have been sending fishermen to my premises outside normal business hours having found these fishermen without licences. Licences will in future be on sale 9a.m. to 6p.m. Monday to Friday and I will inform to pass this information to the relevant bailiffs.

With regards to public consultation on the future of Salmon/Sea Trout License and tagging scheme we would like to we would like to make the following submission
Situated on We have been involved in Angling and the sale of licenses. During this time, we have been a major part of the license distribution system and have played a vital and significant role. The current system is in our opinion out dated and in need of change. While we would agree that at present there are too many distributors it is our belief that whatever system is introduced we as knowledgeable, well-known and trusted distributors will still play a very important role. The distributor is the public face and has the job of dealing with anglers who are having problems or who do not even understand the licensing system. This is very important in an area where we deal with visiting foreign anglers many of whom English is not their first language. We have a fishing tackle shop that is open for up to seven days a week in peak season, this includes early mornings, holidays and other times when IFI staff are not available to deal with the public.
The provision of licenses and permits is an integral part of our business and we depend on it. Both the footfall created and the commission earned are very important for the survival of our business. A new system that eliminates us from this will cause a lot of displacement. One import fact that needs to be taken into account in deciding whether to retain a number of key distributors is their relationship and interaction with IFI staff and in particular fishery officers. We as distributors work closely with the staff and have on many occasions been able to predict possible problems. No matter what system is put in place there will at some stage be a failure. This is when a distributor who is available will be very necessary.
Reasons we as distributors should be retained
Available up to seven days per week at times when IFI staff are not. Already set up and experienced in dealing with anglers and issues. Available to provide a paper back up. Available to reissue tags. Are familiar with anglers and are able to talk to and help educate them. We have a proven track record. We have a working knowledge of who's who. As a business we depend on Commission earned and footfall created from License and permit sales
Problems we see with the current system
Anglers find the Current license and tagging system cumbersome. The current paper license is easy to damage. We see this reflected in the poor condition of Licenses presented in the shop.
Recording of tagged fish in the paper log book is difficult especially in wet conditions along the Riverbank. Anglers forget to make returns. Tags are often reused. Anglers complain about numbers of tags allocated. The one-day license is too expensive and stops a lot of Visitors having a go at Salmon fishing. The 21-day license is popular with visiting anglers but most of them visit for two weeks at most.

Our recommendations

We would recommend that anglers who purchase a season license are given five tags for free and thereafter they can purchase up to ten more tags at a cost of ten euro per tag

Make all Licenses National (A) and get rid of the regional (B) license. Charge one price of 80 euro per season.

The Twenty-one-day (R) license be replaced by a Fourteen-day license. Very few if any anglers visit for twenty-one days. Anglers who purchase a Fourteen-day license be given three free tags and can purchase an additional seven tags at 10 euro per tag

The one-day license (S) be changed for a multiple day license. The Angler will be able to choose between one and three days at ten euro per day. Specific dates can be marked. E.g., Monday the 1st of June, Wednesday 3rd of June, Sat 6th June. This would better accommodate visiting anglers (Who are the only anglers buying short term licenses) as they often like to skip days and try other activities while on holiday.

A phone app be developed for displaying license and logging catch

The phone app to be backed up with a credit card sized License and a more use appropriate log book

Reason for back up to phone app

A phone app, while it appears like a good idea will need a lot of trials with the associated errors to fine tune it. It will lead to a lot of problems for fishery officers on the ground and will use a lot of valuable time which could be more beneficial if used in other duties.

Not all angler will have a phone. This is especially true in the case of older angler which unfortunately the vast number of Salmon anglers are.

There may be GDPR issues with Juveniles.

There will be network issues especially in remote locations, the west of Ireland in particular.

We acknowledge that IFI may be dependent on the rod license revenue until we realise that the net income is paltry when costings and implementation is taken into the analysis as we demonstrated to a NIFF meeting in 2012 when the Chairman gave us the forum. Our rod license is a discriminatory, unfair and inequitable tax on our sport and we are part of the campaign to oppose introducing similar on other species angling especially game and wild brown trout anglers. Unlike shooting, the rod license is not related to the gun and serial number, but used to extract a large fee from the angler. The rod license price charged by this state body as the highest in the world including the nineteen NASCO salmon countries on the Atlantic ocean. From a marketing and business perspective we are three times the cost of an anglers budget flight to the honey pot rivers of Scotland who charge nothing for a state license. Their analysis is that they get it back tenfold in tourism revenue and employment in remote areas strengthening the rural economy. There are many potential Moy Valley river economies here that could be developed should the license be reviewed and packaged into the tourism product that would generate €2billion instead of the billion it does today. • We must look at colleague Sportvisserij Nederald in the Netherlands as to how they manage their all species angling, not just salmon, and how they operate the VISPAS or FISHPASS through the angling federations and clubs which proves why participation and promotion has rocketed over the years. As a result quite a bit of abuse from local anglers for licenses with blue tags when they were then told they could not catch a fish without a brown tag, rendering the blue tags absolutely irrelevant. Brown Tag Lottery: This draw system, in my opinion, was an absolute disgrace for a number of reasons. The draws were not done in a transparent manner, held without notice to the public or the license distributors. No official list of brown tag recipients was ever issued (to my knowledge). At the time of the draw the whole country was in a level 5 lockdown yet anglers from far outside the 5km radius were awarded brown tags and many local anglers did not get one. Many of those from outside the area that secured tags proceeded to pass these on to their "friends" here locally, this meant that a select few local anglers had more than one tag while others who have fished and respected (myself included) all their lives were without a brown tag. I also feel that including the U18 (children) in the brown tag draw was extremely wrong, the tags awarded to the children were then passed on to adult licenses. I have never in all my years of selling and distributing the state fishing licenses had so many enquiries on children's licenses! This tells it's own story! think. The transfer of these tags meant the amending of licenses which had been issued by approved distributors in accordance with fishery regulations. I feel very strongly that any amendments to a state license issued by approved distributors should not be changed or amended by other individuals, this makes a mockery of the State License, to me it would render the license null and void. The introduction of a digital system to replace the paper based system would be preferable. Virtually all anglers will have access to a smart phone while fishing. The license should be available for inspection on these devices through an app much like the current Covid cert. Log book entries and records should be completed online and be available for inspection through the app. Fishery officers would have access to the central database so that any angler claiming they did not have their phone with them or that their phone was out of battery could be checked. The first time the applicant registered and paid for their license, the physical tags would be distributed as currently (either by post or by collection from established agents). The tag numbers would be applied centrally to the digital record. Tags would remain live on the anglers record until used and would not expire at the end of the season. The app would let anglers apply for additional tags as required but only when their digital record accounted for all tags used. This would mean anglers would not have to return unused tags at the end of the season which in turn would greatly reduce the number of tags having to be distributed and then redistributed by IFI. A paper based system could be retained for those anglers who were not comfortable using the digital system but that would very much be the exception. As with the current system, angling records would have to be updated in real time by anglers. This would have the distinct advantage of giving IFI instant access to catch numbers to allow for more proactive fishery management on a catchment by catchment basis. The app would also be very helpful in building a fishing community and helping IFI to communicate with their stakeholders. The app could include for example the ability to report illegal activity directly to IFI. In order to encourage take up, the IFI app could also have a personal section to allow anglers to record details of their fishing for their own personal records including water and weather conditions, flies/lures in use, river height, exact catch location etc and picture and video records of their catches. These images and videos could then be shared with IFI or a private network within the app if desired. The app could also have a forum section for feedback and for communication around general items of interest to the angling community. In order to encourage adoption of the new app, first time applicants could receive a discounted rate for the salmon license. The app would then also notify anglers when their license needed to be renewed. If an angler chose not to renew their license, despite app reminders, the outstanding tags on their record would be invalidated.

On the River Lee there is a huge imbalance in the allocation of the Total Allowable Catch between the nets and rods. The draft nets (approx 14 licence holders) had an allocation in 2021 of approx 500 salmon whereas some 300 anglers who fish the Lee had a quota of 189 salmon (sorry but I do not have the exact figures to hand). There is no equity in this distribution and it needs to be reviewed.

## In your opinion, what are the problems with the current Salmon and Sea Trout Licence and Tagging Scheme?

As a recreational angler, I've got no issue with the physical tagging of salmon and sea trout but I do have serious concerns with respect to the Appropriate Assessment Screening (Invas 2000), which underpins the current salmon and sea trout bye-law and the management of open fisheries with a harvest surplus particularly Lough Corrib SAC. Based on 2020 data, the 2021 'Conservation Limit (CL)' for Atlantic salmon entering Lough Corrib SAC was 7,551 fish with a harvestable surplus of 4,540. In plain English, this means that 4,540 salmon could be harvested this year and still have a sustainable population remaining in the system. This data is based on the fish counter at the Weir in Galway but doesn't take in to consideration the health of the spawning rivers upstream. Even though consistent numbers of salmon have been returning to the Corrib system on an annual basis in recent years, this gives a "false positive" in relation to the overall health of the system. For example, the Owenriff Catchment a key salmon nursery within the Corrib system, which straddles two SACs has been decimated by an illegal introduction of invasive pike. Pike have severely impacted the Owenriff and its ability to produce smolts for downstream migration to the sea. Under current metrics used by IFI and the Dept. of Environment, this impact is airbrushed over by solely using Weir based counter numbers. As a consequence, the validity of the 2020 Invas prepared Appropriate Assessment Screening could be potentially challenged in court as it fails to assess the impact of invasive fish species on Irish salmon stocks in SACs. In an IFI report published this year, 'The Status of Irish Salmon Stocks in 2020 with Catch Advice for 2021. Report of the Technical Expert Group on Salmon', the following statement was made with respect to small salmon populations; "Although these are insignificant fisheries (accounting for less than 0.5% of the total national rod catch when combined), their stocks are important as spawning populations in their own right, which must be maintained as constituent elements of biodiversity, as required under the EU Habitats Directive". In other words, all individual salmon stocks irrespective of population size are important and must be maintained in a favourable conservation condition as per the primacy of EU law. Therefore, the question must be asked, are IFI allowing the Galway Weir counter numbers to mask the problems with the Owenriff Catchment in a bid to sidestep the EU Habitats Directive? If the EU Habitats Directive was being adhered to properly, all salmon producing tributary rivers within Lough Corrib SAC should have fish counters installed to properly assess overall Corrib stocks and to pinpoint underperforming nursery rivers. Furthermore, the current regulations for open fisheries should be consistent with local rules. For example in the Galway Weir Fishery, there is a current local rule for a bag limit of 1 fish [multi-sea-winter salmon (fish of 3.63kg/8lbs+)] per angler up to August 31st. This rule was introduced as a "further conservation measure". However, this local rule undermines the very premise of the conservation limit and the surplus calculated each year for Lough Corrib SAC. Either the Corrib is a sustainable fishery or not but please don't have asinine local rules for a small section of the Corrib River that make no negligible difference to overall stocks. This local rule regarding multi-sea-winter-salmon looks even more ridiculous when an angler holding a valid licence fishing legitimately 400 metres upstream at UCG can potentially harvest 3 multi-sea-winter-salmon in one day between May 12th and August 31st. Finally, IFI need to cease the promotion of 'CPR (catch, photo, release) angling' on open fisheries. CPR angling makes no material difference to open fisheries that have a harvestable quota. IFI and Dept. of Environment documentation support this position. If IFI deem that CPR angling should be promoted on a particular open river/system/catchment for conservation purposes then that open system should be really be closed to all rod and line angling. IFI cannot have their cake and eat it. In recent times this nonsense reached its zenith when the slogan 'choose catch & release' was printed on its blue gill tags for harvested fish. The irony was obviously lost on some.



Of course, the license and tagging scheme can only do so much, and there is a lot of long-term damage done to salmon and seatrout stocks by problems with water quality in rivers, salmon farming, illegal fishing, along with impacts of rising sea temperatures and overfishing of prey fish at sea for fishmeal production etc. I really believe an awful lot more work could and should be done around the improvement of spawning streams, and habitats for juvenile salmon and trout. From my experience, a lot of these are badly overgrown with weeds and obstructions. I have heard that some clubs and associations have requested assistance with this work, and were either put off by high levels of bureaucracy, or met resistance from the relevant authorities. I would have thought that if there are some fisheries who are leading in this area, and encouraging greater recruitment of juvenile fish as a result, that other rivers should be able to adopt similar practices. I feel that the river Suir in particular which is nearby is a case in point: choked with weeds and where the spawning beds should be has practically no gravel: it's all mud and silt! Likewise it is really sad to see the river Mulcair which has multiple tributaries, with miles and miles of potential spawning beds, deteriorate into its present state. It is not that long ago that we used to regularly encounter salmon while fishing wet flies for trout. I heard of hardly any salmon caught there this year, even by the dedicated local anglers. They also report that they never saw sight nor sound of any fisheries officers on the riverbank this year!

The current form of recording fish on paper logbooks should remain for now but could be phased out over time if an alternative system, such as online app, is successful. 2.Collection of improved catch data via an online app would appeal to many anglers. Using a diary type theme, anglers can input catches which would offer real time data on a river specific basis and allow monitoring of quotas. This tool could also be used to generate angler catch per unit effort, river specific catch per unit effort and general observations such as fish seen. This catch data could then be correlated with environmental parameters such as river flows and water temperatures to offer a more forensic look at catches. A more frequent theme on rivers such as the Bandon now is angling conditions are sub-optimal for catching salmon during the prime, summer months due to lower flows. However, logbooks do not show this data and do not always accurately reflect runs of fish. Anglers registering for the app can be given a unique ID number to enable distributors to give them tags. 3. More attention needs to be put on recording catch data for sea trout of all sizes. Keep the tags for 40cm plus fish if a tagging system remains but provide a system to log sea trout under this size also to give an overall idea as to what populations are like on specific rivers at the moment. Sea trout have been overlooked for far too long and a logging system was strongly encouraged at the Sea Trout Symposium held in Dundalk in 2015.

Please find below several points regarding the tagging system management.

Salmon Watch Ireland would like the following issues addressed to aid the conservation of Atlantic salmon. The issues mentioned regarding the management of the tagging scheme are designed to safeguard firstly the conservation status of Atlantic salmon while allowing a sustainable science-based exploitation of available surplus in catchments deemed to be above their conservation limit.

While not specifically related to the management of the tagging scheme, the issue of closing rivers to angling must be reversed. There is certainly anecdotal evidence that rivers that are closed are suffering a disproportionate level of illegal exploitation and thus the presence of anglers will help to alleviate this situation. Many of these rivers that are closed are data poor and thus having angling on a catch and release basis will help to strengthen data collection regarding stocks.

Another issue is that the introduction of an online digital licence must be addressed as soon as possible. This will give an opportunity to engage in real time management. We have suggested a small but important element to facilitate management of surpluses in real time in the points raised.

Our policy would also support a moratorium on commercial exploitation especially on rivers with a relatively low surplus. In the longer term with continued fluctuation in survival indices it may be pertinent to examine the issue of commercial exploitation and indeed recreational exploitation with a view to reducing exploitation

#### **Commercial Fishery**

- Commercial fishery should only commence on 01 June. This is to protect multi sea winter salmon.
- The commercial catch should be subject to restriction based on non-transferable quota for both June and July. Tags should be colour coded to reflect June or July.
- The processing of commercially tagged fish should allow the tag number to be confirmed on all packaging regarding smoking. It is difficult now to trace fish origin especially when salmon is smoked and packaged. This should be subject to periodic audit.

There would appear to be a very limited scope going forward to allow the continuation of a commercial fishery and Salmon Watch Ireland is supportive of a scheme to alleviate losses to the commercial sector.

#### Recreational Fishery

- Spring Salmon restrictions should be extended by period to the 31 May (One fish per day with maximum of 3 Tags during this period.) There should be a requirement to report catch before any additional tags are issued post 31 May. This could be facilitated by an online return which could issue a unique number to be presented to licence distributer.
- Angling tags post 01 June should be limited to issue of three at a time. Again, as above an online return could facilitate this.
- Consideration should be given to restricting tags in September which might limit the total number per angler at this critical juncture in the salmon life cycle (Similar to Salmon Watch Ireland 59 Amiens Street, Dublin 1 Post Code DO1P786
- Spring Period). While acknowledging that this may not be scientifically important it could help to improve behaviour and limit the exploitation of coloured / gravid fish.
- Consideration should be given to juvenile licences being issued with colour coded tags to minimise transfer. There is anecdotal evidence that tags are transferred illegally.
- There must be a more robust identity component required for the issue of a licence. Without proof of identity, it is possible to acquire multiple licences and tags. This may be addressed by an online licence scheme when introduced.
- Regarding individual rivers consideration must be given to categorise rivers based on strength of surplus. It might be possible to eliminate brown tags restricting certain rivers to a small individual catch per angler.

Although the commercial fishing sector has a set season of 10 weeks and every fish is accounted for and tagged with 100% return rate of data the angling sector who are majority users of the resource now are only 56 % compliant in terms of log book returns. Considering they catch 78% of the salmon catch nationally this is shocking as all the efforts to manage the salmon stock depend on good data. We went from a situation where there was huge amounts of data coming from the catch sector to depending only on the angling and commercial draft sector and although the logbook returns are 100% for the draft men they only catch 22% of catch nationally.

By increasing the level of angling logbook returns so that modeling and predictions of salmon stocks can be as accurate as possible. We were always told about the importance of accurate data to run the model but since the drift netting ban the logbooks return therefore data had decreased. As this keeps happening the prediction of the salmon coming back keeps going down. Given that the commercial draftnet catch is capped the true level of salmon returning to the rivers is never accurately recorded except where there are working counters. Because of this the total allowable catch will never increase to reflect the stock levels therefore it is absolutely vital that the angling returns are recorded as accurately as possible and fed into the management as quickly as possible. There is no point in asking an angler who has returned home to fill a logbook at the end of the season. Each commercial draftnets man has to apply for a license and is personally known to IFI inspectors however this is not possible for every angler but they should have to show their identification when buying an angling license and getting their tags. This would ensure they submit logbook return before they get more tags. It is our opinion that in the draftnet situation at the moment it is run very efficiently by IFI and would like to see it remain that way.

### In your opinion, what are the problems with the current Salmon and Sea Trout Licence and Tagging Scheme?

As a recreational angler, I've got no issue with the physical tagging of salmon and sea trout but I do have serious concerns with respect to the Appropriate Assessment Screening (Invas 2000), which underpins the current salmon and sea trout bye-law and the management of open fisheries with a harvest surplus particularly Lough Corrib SAC. Based on 2020 data, the 2021 'Conservation Limit (CL)' for Atlantic salmon entering Lough Corrib

SAC was 7,551 fish with a harvestable surplus of 4,540. In plain English, this means that 4,540 salmon could be harvested this year and still have a sustainable population remaining in the system. This data is based on the fish counter at the Weir in Galway but doesn't take in to consideration the health of the spawning rivers upstream. Even though consistent numbers of salmon have been returning to the Corrib system on an annual basis in recent years, this gives a "false positive" in relation to the overall health of the system. For example, the Owenriff Catchment a key salmon nursery within the Corrib system, which straddles two SACs has been decimated by an illegal introduction of invasive pike. Pike have severely impacted the Owenriff and its ability to produce smolts for downstream migration to the sea. Under current metrics used by IFI and the Dept. of Environment, this impact is airbrushed over by solely using Weir based counter numbers. As a consequence, the validity of the 2020 Invas prepared Appropriate Assessment Screening could be potentially challenged in court as it fails to assess the impact of invasive fish species on Irish salmon stocks in SACs. In an IFI report published this year, 'The Status of Irish Salmon Stocks in 2020 with Catch Advice

for 2021. Report of the Technical Expert Group on Salmon', the following statement was made with respect to small salmon populations; "Although these are insignificant fisheries (accounting for less than 0.5% of the total national rod catch when combined), their stocks are important as spawning populations in their own right, which must be maintained as constituent elements of biodiversity, as required under the EU Habitats Directive". In other words, all individual salmon stocks irrespective of population size are important and must be maintained in a favourable conservation condition as per the primacy of EU law. Therefore, the question must be asked, are IFI allowing the Galway Weir counter numbers to mask the problems with the Owenriff Catchment in a bid to sidestep the EU Habitats Directive? If the EU Habitats Directive was being adhered to properly, all salmon producing tributary rivers within Lough Corrib SAC should have fish counters installed to properly assess overall Corrib stocks and to pinpoint underperforming nursery rivers.

Furthermore, the current regulations for open fisheries should be consistent with local rules. For example in the Galway Weir Fishery, there is a current local rule for a bag limit of 1 fish [multi-seawinter salmon (fish of 3.63kg/8lbs+)] per angler up to August 31st. This rule was introduced as a "further conservation measure". However, this local rule undermines the very premise of the conservation limit and the surplus calculated each year for Lough Corrib SAC. Either the Corrib is a sustainable fishery or not but please don't have asinine local rules for a small section of the Corrib River that make no negligible difference to overall stocks. This local rule regarding multi-seawinter-salmon looks even more ridiculous when an angler holding a valid licence fishing legitimately 400 metres upstream at UCG can potentially harvest 3 multi-sea-winter-salmon in one day between May 12th and August 31st. Finally, IFI need to cease the promotion of 'CPR (catch, photo, release) angling' on open fisheries.

CPR angling makes no material difference to open fisheries that have a harvestable quota. IFI and Dept. of Environment documentation support this position. If IFI deem that CPR angling should be promoted on a particular open river/system/catchment for conservation purposes then that open system should be really be closed to all rod and line angling. IFI cannot have their cake and eat it. In recent times this nonsense reached its zenith when the slogan 'choose catch & release' was printed on its blue gill tags for harvested fish. The irony was obviously lost on some.

An improved Appropriate Assessment Screening for the 2022 Salmon and Sea Trout Licence/Tagging Scheme needs to be produced particularly for the bigger catchments such as Lough Corrib SAC as the current Invas produced screening wouldn't stand up to legal scrutiny in an Irish or European Court. 2. The promotion of 'CPR angling' on open fisheries must cease.
- 3. Local fishery rules for open systems must not conflict with national or local licence rules such as the current nonsensical rules for the Galway Weir fishery as discussed under question 1. 4. The creation of a licence app and QR codes on gill tags to aid data collection and processing.

## In your opinion, how can Inland Fisheries Ireland improve the Salmon and Sea Trout Licence and Tagging Scheme?

The rod license system is archaic and a failed entity which needs to be examined in the NIFF context so that a successful pathway to progress is agreed among all involved. We must look at the international market to attract angling tourism and compare notes on why Scotland is still the forerunner in salmon anglers visiting their rivers. We acknowledge that IFI may be dependent on the rod license revenue until we realise that the net income is paltry when costings and implementation is taken into the analysis as we demonstrated to a NIFF meeting in 2012 when the gave us the forum. Our rod license is a discriminatory, unfair and inequitable tax on our sport and we are part of the campaign to oppose introducing similar on other species angling especially game and wild brown trout anglers. Unlike shooting, the rod license is not related to the gun and serial number, but used to extract a large fee from the angler. The rod license price charged by this state body as the highest in the world including the nineteen NASCO salmon countries on the Atlantic ocean. From a marketing and business perspective we are three times the cost of an anglers budget flight to the honey pot rivers of Scotland who charge nothing for a state license. Their analysis is that they get it back tenfold in tourism revenue and employment in remote areas strengthening the rural economy. There are many potential Moy Valley river economies here that could be developed should the license be reviewed and packaged into the tourism product that would generate €2billion instead of the billion it does today. • We must look at colleague Sportvisserij Nederald in the Netherlands as to how they manage their all species angling, not just salmon, and how they operate the VISPAS or FISHPASS through the angling federations and clubs which proves why participation and promotion has rocketed over the years. The angler is charged for local angling based on a radius from the home of the VISPAS address which is logical. Anglers are still being charged for two districts whether they live on the borders of the district or not. Eq I live , which is in the district, but if I fish upriver and want to change to the Owenea river a few miles away, I will have to pay for another new license of €56 as it is in the Letterkenny district. The tagging system has been a very costly failure that never delivered the objectives of identifying the accurate collation of statistics which were used then to open and close rivers unfairly. The sooner our clubs data is used to verify the IFI logbook returns, the sooner the river by river data will become more accurate
