Dear All,

Inland Fisheries Ireland is seeking submissions from interested parties in relation to a proposal to introduce a byelaw to:-

- Introduce a minimum takeable size limit for trout of 30 cm (12")
- Introduce a bag limit of two trout per angler per day

The proposed byelaw would apply to all waters of the River Erne upstream of Derryheen Bridge, west of Butler's Bridge, Co. Cavan (Nat. Grid Ref. 54.0378, -7.4018) including the waters of the Cavan River, Annalee, Dromore, Laragh, Bunnroe and Knappagh tributaries.



The club has a number of foreign anglers who enjoy fishing on our rivers.


This was ratified by the 74 members of our club at an EGM held on Thursday 9th February 2017.

Good day,

Just one suggestion about this subject: why not trying a size window for brown trout? This is effective in a good number of US rivers and is proven efficient:

- there is almost always a large amount of sub-adult fish that might be taken;
- this prevent the trophy fish to be killed and gives value to the fishery;
- this keep a substantial amount of large and efficient breeders in the river.

Obviously I won't propose any size as I do not know the catchment characteristics but it looks like the fish from age classes 2 and 3 years could be killed and all others shall be released.
