

Expression of Interest to Participate in Tuna CHART – CatcH And Release Tagging: Atlantic Bluefin Tuna Data Collection Programme

Prospective applicants for Section 14 authorisations to target, catch, tag and release Bluefin tuna off the Irish coast in 2019 should fill in the form below as fully as possible.

Please note the following:

- Table 1 lists minimum criteria for qualifying vessels. Applicants will only be considered if their vessel passes all criteria in Table 1.
- Copies of all supporting documents are required with this application. Please tag all files with your name if sending electronically.
- Mandatory attendance at a training course will be required for all Bluefin tuna Section 14 holders.
- Fitting and operation of a simple vessel monitoring system (VMS) may be a requirement of the authorisation.
- Section 14 authorisations will be issued following training and final boat inspection. Verification of boats and equipment will be carried out by local IFI fisheries officers at the boat port by prior arrangement. Failure to have any of the required documentation or equipment will result on the non-issuing of the authorisation.
- Authorisations will be awarded on a proportional basis, based on the distribution of eligible applicants.
